2008 will be a landmark year for Alabama and the field of interpreting - a new interpreter training program is scheduled to open at Troy State University in fall 2008, bringing to Alabama the only program of its kind and the state's first bachelor's degree in interpreting! This program will open less than an hour from Montgomery – the site of our 2008 conference!

The members of ALRID recognize this as the perfect opportunity for us to spend the conference prior to this historic moment focusing on our FIELD! ALRID 2008 will bring together interpreters from all stages within our profession – from those with many years of experience to those who are just beginning the journey towards becoming an interpreter – to share knowledge, resources, wisdom, perspective, goals, support, and guidance. This conference will have something for everyone – whether new or seasoned!

What a great opportunity to have a meeting of the minds among Alabama interpreters and interpreters from around our nation to pursue a strong consensus on issues such as our code of professional conduct, to clarify state licensure and credentials, to exchange information about the business of interpreting, and to build unity among us as we head into this new chapter in both Alabama's history and the overall field of interpreting!

We will have a variety of workshops on Friday and Saturday, all focused on our FIELD and the profession of interpreting to meet the interests of all:

• Keynote presentations on RID at the national, state, and local levels

- Leadership within our profession
- An analysis of our code of professional conduct as it applies to various fields of expertise (community interpreting, educational interpreting, vocational rehabilitation interpreting, etc.)
- Alabama state licensure and updates that recognize the Educational Interpreters Performance Assessment (EIPA) for state permits and licensure
- Wisdom regarding the business of interpreting (taxes, incorporation, sole proprietorship, invoicing, contracts, how to get started, contacts in Alabama, etc.)

This is the conference to attend in 2008! Join us in Montgomery, AL July 25 – 26, 2008 for this important event – and be a part of this milestone year for our field! The conference will be held at the Renaissance® Montgomery Hotel & Spa at the Convention Center, so while you're learning more about the profession you can also find some time to pamper yourself!
