# Alabama Registry of Interpreters for the Deaf Annual General Board Meeting June 16, 2017 Minutes

Call to Order at 12:16pm.

**Program:** Chris started off the meeting by dissecting the ALRID mission. The ALRID mission is as follows:

The principal objective of ALRID shall be to promote policies and activities that will further the profession of interpreting by initiating, sponsoring, promoting and executing events statewide that will further the profession of the interpretation of American Sign Language and English.

Chris then focused on the word "further" by discussing the dictionary meaning and also the impact it has for non-Profit Organizations. Nonprofits with a high impact focus on inwardly building growth to pour energy externally to catalyze large scale change. To do this we need to serve and advocate, make markets work, inspire volunteers, nurture networking, master the art of adaptation, and share leadership. Chris closed by reminding us all that "Growth is never by mere chance; it is the result of forces working together." (James Cash Penney, Founder of JC Penney).

#### President Report 2016-2017

Two areas that have been critical are LEAD-K and the CDI Cohort. Both have allowed ALRID to advocate and promote the interpreting profession and Deaf community here in Alabama. Both of these will be continued initiatives for 2017-2018.

Also as president I represented ALRID at TRID board retreat. The secretary and I were asked to lead and facilitate their board retreat. It was amazing to walk alongside TRID as they developed their vision and action plan, as well as a great way for ALRID to lead and serve the interpreting profession.

I look forward to representing ALRID at the RID national conference in July 2017, as well as continuing to follow and act on our vision to Lead, Serve, and Connect.


# ALRID SECRETARY / PR (MEMBERSHIP) / WEBSITE REPORT JUNE 2017 - GENERAL BUSINESS MEETING

In September we held an ALRID Board Retreat at Camp McDowell. There, with little to no cell phone service, no wifi, and a lot of dialoguing, we were able to really discuss what we wanted this board to achieve over the next 2 years. We left with an abbreviated vision of "Lead. Serve. Connect." (The un-abbreviated version is "Leading the interpreting profession, Serving the interpreting community, and Connecting to the Deaf community".) Our focal points being communication, approachability, transparency, involvement/engagement/diversity/outreach, consistency, and history/roots/future. This has guided most, if not all, of the activity done on not only my part but our part as a board.

Due to circumstances outside of our control, we needed to launched a NEW facebook page in September. To date, the new page has a total of 213 likes. We have uploaded 4 videos and roughly 30 pictures. Our "biggest hit" has been the "Interpreter Appreciation Video" uploaded in May which has reached just over 5,000 people and been viewed just over 2,000 times. We have distributed two newsletters. Our November newsletter was delivered to 340 members (both lapsed and active) with 163 (48%) of those emails being opened. The Q1 2017 newsletter was delivered to 273 members with 114 (42%) being opened.

As you can see from the graph below, our membership has greatly increased! We have had a 11% increase over last year with our total membership hitting 162 (including 2 organizational members). This is largely in part to the Regional Meet and Greet's that have been held, our Membership Specials that have been offered, and the ALRID board getting out and "mingle-ing" with our constituents. At this time we have 140 lapsed members. The contacts list with our website platform is nearing its maximum, so we will be archiving any old/lapsed members soon.



The website (<u>www.alrid.org</u>) has been and is continuing to be updated. This is a large task that Daniel Lute and I have been working on. Any previous minutes that we have available are being uploaded, as are previous newsletters. We are missing some information. If you have any records of anything before 2000 or from 2010-2014, please contact Diana or Chris.
